## General Information:

- **No move-ups will be permitted at this trial.**

Competitors who qualify for an AAC title prior to the trial may move up **providing** the Trial Secretary receives the information **at least 5 days prior to the trial date.**

**Obstacles may include:** A-frame, Weave Poles, Flexible Tunnels, Tire Jump (break-away), Spread Jump, Double Bar Jumps, Single Bar Jumps, Broad Jump.

## **A Break-away self-healing tire and electronic timing will be used at this trial**

There will be no familiarization, but two jumps will be set up in a practice area for the duration of the trial.

## **Awards:**

- Placement ribbons for 1st through 4th place for each division
- Qualifying rosettes for all AAC agility qualifiers
- Titling rosettes acknowledging dogs who achieve an AAC agility title

**Facilities:** The trial will be held outdoors in a fully fenced grass rings. Washrooms are available as well as parking near the ring. There's plenty of room for tents and crates, and spectators are more than welcome. The event will still run in the event of rain.

## **Volunteers:**

Any volunteer help you can provide at the time of the trial would be much appreciated. We are working with More Dogz to use an electronic sign-up sheet. Snacks and beverages will be available for **volunteers.**

There is a fenced off-leash play area and acres of land to walk your dog on a leash during the trial. We do ask that you poop-n-scoop and keep your dog on a leash or crated when outside of the agility rings as there is livestock and electric fencing on the property.

## **Directions:**

3859 Carling Avenue ~ Nepean, Ontario  
From the 417 take the March/Eagleson exit and go north (right if you're travelling west, left if you're travelling east). Turn right at the lights at Herzberg Road – cross the railway tracks – turn right at the lights at Carling Avenue. Dogz is the first driveway on the left.  
From Carling, go west past Moodie Drive – under the train bridge – Dogz is the last driveway on the right before you get to the lights at Herzberg Road.  
PARKING will be located by the agility rings –just follow the signs at the end of the driveway.

## **Notice to Competitors:**

All dogs must have an AAC ID number to compete, There shall be no refunds for entries withdrawn after the closing date, or in the event that a dog and/or handler are dismissed from the trial, regardless of the reason, or in the event of inclement weather. Refunds will be issued for dogs that come into season or are injured, providing a veterinarian's certificate is received by the Trial Secretary within 48 hours of the trial date.

In consideration of the acceptance of this entry by AAC and DOGZ CANINE SPORTS CENTRE (the “Organizing Club”) and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the “Event”), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my “**Related Parties**”), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the “**Personnel**”) for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers’ fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:
  - (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
  - (b) aggressive behaviour by the Dog or any other dog under my control.
5. I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the “**Rules**”). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.
6. I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.

**Media Release & Rights of Privacy Waiver**

I Hereby Grant to AAC and its affiliated companies, representatives, agents and assigns, all rights and permission to use or appropriate his/her and their dog’s name, biography, likeness, photograph, voice, performing persona, or other indicia of identity for broadcast, telecast, cablecast, transmission or distribution in any format or media known now or in the future.
